INSTRUCTIONS

- <u>Line 1:</u> Amount of gross receipts from sale of alcoholic beverages of each establishment within the city limits licensed to sell alcoholic beverages, by package or by drink. The fee is to be remitted to the City on a quarterly basis with the amount remitted based on the gross receipts for that respective quarter.
- <u>Line 2:</u> The regulatory license fee imposed is three percent (3%) of the gross receipts from the sale of alcoholic beverages.
- <u>Line 3:</u> A credit of ¼ (one-fourth) of the cost of the City of Hazard annual alcoholic beverage license shall be deducted from the regulatory license fee each quarter.
- <u>Line 4:</u> An interest rate of 8% per annum will be imposed from the due date until the date of payment.
- If the business does not comply with the regulatory license fee ordinance, the City may suspend or revoke the business's City of Hazard alcoholic beverage license.
