## INSTRUCTIONS

1. City of Hazard Ordinance Chapter 111, Alcoholic Beverages, §111.27: Regulatory License Fee, imposes a regulatory license fee upon the gross receipts from sale of alcoholic beverages of each establishment within the city limits licensed to sell alcoholic beverages, by package or by drink. The fee is to be remitted to the City on a quarterly basis with the amount remitted based on the gross receipts for that respective quarter.
2. The fee imposed is one and one-half percent (1.5%) of the gross receipts from the sale of alcoholic beverages.
3. A credit shall be allowed to each business against the regulatory license fee equal to the City of Hazard annual alcoholic beverage license fee imposed per §111.20, Classification of Licenses, Fee Schedule. The business will deduct the annual City of Hazard alcoholic beverage license fee amount during the second quarter of the year after the business's City alcoholic beverage license is renewed in April.

The regulatory license fee is assessed to reimburse the City for additional policing and regulatory or administrative expenses related to the sale of alcoholic beverages in the City. The regulatory license fee shall be in addition to any other taxes, fees, or licenses lawfully imposed upon such establishment.

Penalty; if the business does not comply with the regulatory license fee ordinance, the City may suspend or revoke the businesses City of Hazard alcoholic beverage license. In addition to the revocation or suspension, any fee not paid on or before the due date of the fee, an interest rate of 8% per annum will be imposed from the due date until the date of payment. The City Commission or their designee may, at their sole election, choose to impose a fine of no less than \$50.00 and no greater than \$500.00 per each offense or violation.
