ABC LICENSE RENEWAL INSTRUCTIONS

- Please complete all city and state renewal forms. Payments made to the City of Hazard need to be in the form of check, cashier's check or money order. The City of Hazard does not accept credit/debit or ACH transactions.

-If you are purchasing an existing licensed establishment, you must file for a new license, not a renewal.

-You must have a current City of Hazard business license.

-A City of Hazard ABC license will not be issued if there are any delinquent bills that are owed to the city. (Example: tax bills, business license, etc.)

-You will not receive your city license until after you receive your state license. You must have all renewal information and payment submitted along with a copy of your state license. At that time, I will process your payment, issue and mail your city ABC license to you. We suggest an early start on your State ABC renewal for the year since there are many steps to be completed. This will help with any delay on your city license.

-Quick mail-back checklist for ABC Renewal:

- ABC License Renewal Form and Payment
- Signed Affidavit
- Provide a copy of your current Health Department Inspection (for restaurants and bars only)
- Provide a copy of the new year State license
