



**BLACK GOLD FESTIVAL APPLICATION**

Welcome to the Black Gold Festival license process! We are happy to have you as part of our Black Gold Festival family.

In order to sell goods or services at a permitted special event, all vendors must have a valid city occupational license or a special event vendor license (“Vendor License”). Per ordinance, you may be exempt from paying the vendor license fee, but you still must fill out a vendor application and receive a Vendor License. Please visit the City of Hazard website at [www.hazardky.gov](http://www.hazardky.gov) for additional information including the City of Hazard Code of Ordinances. The special event ordinance can be found in Chapter 114, Miscellaneous Business Regulations, §114.04, Special Events. Once issued, the vendor license is valid for the length of the current year’s festival.
